# **Payments**

Payments must be given on the day of the lesson. Late payment can result in lessons being cancelled or terminated.

### Cancellation

Any lessons cancelled by the Student (or the Student's Parent or Guardian) with less than 48 hours' notice will result in the Deposit being forfeited, unless the Tutor decides otherwise because of exceptional circumstances. If the Tutor is obliged to cancel a lesson, the lesson will be rearranged for a time that is mutually convenient for both Student and Tutor.

#### Lateness

It is important that you turn up on time for your sessions both online or one to one. If you are late for the session, time will not be given back. It will be up to the tutor to decide whether that lesson will go ahead or be rearranged. Please see cancellation regarding deposit being forfeited. If you are late picking up there will be a charge of £3.00 every 5 minutes you are late.

If you are more than 10 minutes late to an online lesson, that lesson will be cancelled and deposit forfeited.

# **Termination of Lessons**

Lessons will continue until a mutually agreed termination date, at which point the Deposit will be returned. Both the Tutor and the Student (or the Student's Parent or Guardian) reserve the right to terminate lessons should they no longer be considered beneficial to the Student.
